1. *The Government of Nepal [GoN] has allocated funds* towards the cost of *Construction Of Administrative Building Of Adanchuli Rural Municipality, Humla* and intends to apply part of the funds to cover eligible payments under the Contract *for Construction Of Administrative Building Of Adanchuli Rural Municipality(05/NCB/ARM/WORKS/2082-83)*. Bidding is open to all eligible as per Section V of bidding document.
2. *Adanchuli Rural Municipality, Shreenagar, Humla* invites electronic bids from eligible bidders for the construction of *Administrative Building Of Adanchuli Rural Municipality* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: *40 Million*
 - Minimum Work experience of similar size and nature: *one contract with the value of 49.95 Million*
3. Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

PM at the office of Adanchuli Rural Municipality. Bids must be valid for a period of ***90 days*** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs.20,60000/-**, which shall be valid for 30 days beyond the validity period of the bid (9th November, 2026).

8. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
